## Purposes

- To address fire alarm notifications to this agency with the goal of reducing false emergency activations.
  - Each false emergent notification costs this agency a fee per call, response resources, operational costs, and administrative time.
- The existing property and building secure access process require assurances that we can access properties without delay.
  - Apartment gates, residential gates, and commercial occupancies

#### Supervision

- General supervision and direction provided by the Fire Chief.
- Receives direction and task assignments from the Assistant Fire Chief, Deputy Chief and District Chiefs.

### **Primary Duties**

- Position is to examine fire alarm systems and gate/entry operations while on duty
- Responsible for time keeping, detailed record keeping and interfacing with the Office Manager and Fire Chief
- The position has no purchasing authority without specific direction from at least one of the chiefs
- Other duties as assigned

## Qualifications

- Good physical condition
- Capable of high-quality interpersonal skills
- Enhanced knowledge of fire alarm systems
- Strong capabilities of Microsoft Office
- Motivated self-starter
- Current Texas drivers license and personal vehicle insurance
- Must be United States Citizen

#### **Work Period**

- This is a part time hourly position with flex time opportunities
   Starting pay \$20 per hour
- The position may attain a maximum of 20 hours per week
- The normal work time begins at 9 am and ends at 4 pm weekdays only
- Pay periods will be within the existing PVFA schedule (every two weeks)

# Tasks to be Performed

- Obtain and utilize data to identify false emergent alarms and emergency alarms
- Create and maintain an accurate data base
- Identify alarm causations and follow up with building owners/tenants

   Interface with the county fire marshal as needed
- Create a system of invoicing for false emergent alarms and pursue same
- Create a system of identifying secure entry addresses and responsible parties
- Assure security entry systems are in proper working order
  - Review entry system requirements as adopted by Harris County with the facility owner/tenant; includes some residential interfacing
  - Communicate as necessary with building/community owners, management, HOA's and the county fire marshal
- Work with the Deputy Chief interfacing data within Responder 360
- Participate as a support emergency responder during major events in district while on duty
- Other related tasks as necessary related to the above
